Risks may include, but are not limited to, injury or damage caused directly or indirectly as a result of dog fights, dog bites, being knocked down, chased or tripped, dog or other pets being injured by motor vehicles, etc. Releasor, for himself or herself, his or her spouse, legal representative or heirs and assigns, hereby assumes the sole responsibility for and agrees to indemnify and hold the Releasees harmless from any and all loss and expense (including legal and expert witness fees) by reason of the liability imposed by Tennessee or other law upon Releasees for damage because of bodily injuries, including death at any time resulting therefrom, sustain by any person or persons, including the Releasor, or on account of damage to property arising out of or in consequence of Releasee's use of the Facility, however such injuries, death or damage to property or persons may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the Releasees.

By signing below, Releasor states that he or she (1) agrees to the terms and conditions described herein, (2) has read and fully understand the Loudon Parks and Recreation Department and the City of Loudon Park Rules attached hereto, and (3) promises to fully comply with all of the conditions for use of the Facility.
