- **No Alcoholic Beverages Permitted**
- **Security Cameras in Use**
- **State Law Prohibits Smoking in Government Buildings**
- **Do not fasten (tape/nail) items to facility walls and doors**

- **Vandalism to your shelter is punishable by Law, including graffiti**

- **Children under 18 require adult supervision**
- **Loud, boisterous, obscene language will not be tolerated**
